CVS Caremark Transform Diabetes Care® will be offered to individuals currently being prescribed medication for diabetes who are enrolled in a HealthTrust medical plan that includes prescription coverage provided by CVS Caremark.® (Individuals covered by a *Lumenos* plan or a *Medicomp Three without Prescription Drug* plan are not eligible for Transform Diabetes Care.)

This comprehensive, voluntary program helps individuals who participate improve their adherence to medication, better monitor their blood sugar and A1C levels, and adopt healthier lifestyle habits. These improvements may, in turn help reduce their risk for potentially life-threatening complications of diabetes.

In January, CVS Caremark® will be sending a Welcome Kit to all eligible HealthTrust covered individuals age 18 or older who are taking prescribed medication for diabetes. The kit explains the program, includes a voucher for two diabetes monitoring visits within one year at any CVS MinuteClinic® location, and offers personalized one-on-one coaching with a CVS pharmacist.

The Welcome Kit also includes instructions for enrolling in the Livongo connected meter program. Individuals who enroll in the Livongo connected meter program will also be offered the following tools for managing diabetes better at no cost to them:

- A free Livongo connected blood glucose meter that automatically uploads blood sugar data to a secure account to share with their doctor or anyone they choose.
- Live interventions triggered by acute alerts.
- Test strips and lancets shipped directly to the participant.
- Guidance from a Certified Diabetes Educator.
